(1) This salary measure is intended to capture an indication of responsibility level only and should not be used to reflect total salary earnings or total employment cost over the 2007-2008 financial year. For this reason, all part-time employees' salaries are reported as the amount employees would receive if they worked full-time.

(2) Salary details relate to pre-tax income excluding Super and FBT. Non-executive employees on salary sacrifice arrangements are shown as pre-sacrifice values. Executive remuneration is calculated according to a Total Remuneration Package Value (TRPV), which identifies both salary (taxable income) and non-monetary benefits, which includes motor vehicle and the governments' employer superannuation contribution. Allowances are excluded for all employees.

(3) The salary brackets have been constructed as an indication of the level of responsibility, and are based on the remuneration structure of the PSM Act Administrative Services Stream at June 2008

(4) The Adelaide Convention Centre (ACC) did not supply detailed employee data for June 2008. Where possible, figures from the ACC Annual Report have been used.
